# UPDATE ON ANKARA CENTRE ACTIVITIES

SESRTCIC JOINTLY
ORGANISES A
CONFERENCE ON
"STRENGTHENING SMALL
AND MEDIUM-SIZED
ENTERPRISES FACING
GLOBALISATION AND
LIBERALISATION" IN ABU
DHABI, UAE

The Conference on "Strengthening Small and Medium-Sized **Enterprises** Facing Globalisation Liberalisation" was held on 21-22 May 2000 in Abu Dhabi, U.A.E. It was jointly organised by the Ministry of Economy and Commerce (MEC) of the United Arab Emirates, the Abu Dhabi Chamber of Commerce and Industry (ADCCI), the Islamic Development Bank (IDB) and the Statistical, Economic and Social Research Training and Centre for Islamic Countries (SESRTCIC). Conference was held under the patronage of H.H. Sheikh Dr. Sultan Bin Khalifa Al Nahyan, Executive Council Member. Chairman of the Office of H.H. the Crown Prince of Abu Dhabi and

Honorary President of Abu Dhabi Chamber of Commerce and Industry.

Director General Ambassador Erdinç Erdün, Assistant Director General Dr. Abdelrahman Zeinelabdin and Director of Technical Cooperation Department Mr. Selim Ilkin represented the Centre at the Conference.

The main objectives of the Conference were to discuss and provide answers to the following questions:

1. What are the impacts of liberalisation and globalisation on the Small and Medium Scale

Manufacturing Enterprises (SMEs) and what types of domestic, regional or OIC-level measures are needed to overcome the adverse impacts?

- 2. What is the role of the domestic environment (financial, legal, economic, etc.) in the promotion and effectiveness of SMEs?
- 3. Are there OIC countries in which liberalisation and globalisation had a positive impact? What are the main factors which contributed to this positive result?
- 4. What intra-OIC Cooperation is needed to promote SMEs?

Twelve participants from eight countries (Bangladesh, Egypt, Jordan, Lebanon, Malaysia, Qatar, Turkey, United Arab Emirates) and four institutions (Islamic Centre for Development of Trade (ICDT), Islamic Chamber of Commerce and Industry (ICCI), United Nations Industrial Development Organisation (UNIDO) and Islamic Development Bank (IDB)) attended the Conference. The participants were well selected and all of them were keenly interested in the subject matter.

During the opening session, speeches were delivered on behalf of H.H. Sheikh Dr. Sultan Bin Khalifa Al Nahyan, Executive Council Member, Chairman of the Office of H.H. the Crown Prince of Abu Dhabi, Honorary President of the Abu Dhabi Chamber of Commerce and Industry and H.H. Sheikh Fahim Bin Sultan Al-Qasimi, Minister of Economy and Commerce of the U.A.E. Ambassador Erdinç Erdün, Director General of SESRTCIC, also delivered a speech expressing his satisfaction with the arrangements for the Conference and touching upon the role of SESRTCIC within this context.

International and regional experts presented papers aimed at analysing the following issues:

- What kind of policy instruments can effectively be utilised in support of the development of SMEs in view of the international constraints imposed by various agreements leading to the WTO charter? Specifically what are the implications of globalisation and liberalisation?
- Importance of transfer of technology, opening export markets and financing of production of the SMEs in the developing economies.
- Profiles of change in manufacturing industries in the developing countries with specific reference to the SMEs: Factors leading to best practice policies.
- Assessment of policies supporting and stimulating the development of SMEs: Recent Experience.
- Role of regional and international organisations in the promotion of SMEs.
- Cooperation between public and private sectors and Islamic regional cooperation for the promotion of SMEs.

The Conference has been highly rated by the participants in terms of its organisation and topical coverage. SESRTCIC will edit the papers that were presented at the Conference as well as the final report. They are to be submitted to the Sixteenth Meeting of the COMCEC which will be held in Istanbul on 23-26 October 2000.

#### **DEVELOPMENTS IN THE SESRTCIC WEB SITE**

Strong with the support of its users, more than 11.500 visitors since 19 January 2000, SESRTCIC Website continues to improve the quantity and quality of its information. In terms of statistical information, the Website provides data on 194 indicators for 56 OIC member countries, from 1975 to the latest available data year. This is the biggest and most comprehensive on-line statistics database on the OIC countries. It is also the most visited part of our web site. More statistical information will be accessible to our visitors once the on-going process of links to the National establishing Statistical Institutions of all 56 member countries is complete.

The Website is being enriched with other material. First, the latest issue of the Journal of Economic Cooperation in English (Volume 21, Number 2). It is now accessible and it includes four downloadable articles. Second, the

conversion of the web pages into Arabic is proceeding smoothly with daily additions. Thirdly, we shall be shortly including a list of Research and Training Institutions of the OIC member countries and giving links to those that have their own web sites. This will enable our visitors to obtain information on research and training activities in a more structured and timesaving manner.

Regarding technical developments, our web site has changed its outfit in order to be even more user-friendly. There is now a new menu bar at the top of the screen, which is accessible from any pages visited, and our new search facility enables keyword searches on our entire site and gives result lists that match the inquired keywords. Finally, we shall soon be moving on to a server that will enable faster access to our web pages and minimise the risk of technical problems for our visitors.

#### **OIC NEWS**

### THE 16TH MEETING OF THE FOLLOW-UP COMMITTEE OF COMCEC AGREES TO GIVE MORE EMPHASIS TO THE AREA OF TECHNICAL COOPERATION

The 16<sup>th</sup> Meeting of the Follow-up Committee of the Standing Committee for Economic and Commercial Cooperation of the OIC (COMCEC) took place in Istanbul, Turkey on 9-11 May 2000. The Meeting was attended by nine (out of ten) member countries of the Follow-up Committee, by the OIC General Secretariat, and by Subsidiary, Specialised

and Affiliated OIC institutions. Director

General Ambassador Erdinç Erdün and Assistant Director General Dr. Abdelrahman Zeinelabdin represented the Centre at this Meeting.

The Committee took up the following Agenda items:

- A background report by the OIC General Secretariat on the progress achieved in the implementation of the COMCEC projects.
- Review of the implementation of the Plan of Action to Strengthen Economic and Commercial Cooperation among OIC Member States.
- Report by the Islamic Development Bank (IDB) on the Expansion of Intra-OIC Trade in the 21<sup>st</sup> Century.
- Matters relating to the World Trade Organisation (WTO).
- Preparation for the Exchange of Views on "Strengthening Small and Mediumsized Enterprises Facing Globalisation and Liberalisation", to be organised during the 16<sup>th</sup> Session of the COMCEC.
- Draft Agenda of the 16<sup>th</sup> Session of the COMCEC.

After extensive deliberations the Committee agreed to:

• Emphasise the importance of implementing the existing Agreements and Statutes in the area of economic cooperation.

- Recommend to the 16<sup>th</sup> COMCEC a number of measures to accelerate the implementation of the OIC Plan of Action.
- Urge Member States to expedite the action for convening Expert Group Meetings and the formation of project committees with a view to expediting the implementation of the Plan of Action.
- Urge the OIC General Secretariat and the IDB to maintain their assistance to the Member States in matters related to the WTO.
- Request the OIC General Secretariat, COMCEC Co-ordination Office and other related OIC institutions to make arrangements for an effective and indepth exchange of views on the subject of "Strengthening Small and Medium Sized Enterprises Facing Globalisation and Liberalisation".
- Propose the convening of the 16<sup>th</sup> Session of the COMCEC from 23 to 26 October 2000 in Istanbul.

## 27TH ISLAMIC CONFERENCE OF FOREIGN MINISTERS REVIEWS OIC ACTIVITIES

The 27th Islamic Conference of Foreign Ministers (ICFM), Session of Islam and Globalisation, was held in Kuala Lumpur, Malaysia from 27 to 30 June 2000. Director General Ambassador Erdinç Erdün, Assistant Director General Dr. Abdel Rahman Zeinelabdin and Acting Director of Administration and Finance Mr. Jalel Chouchane

represented SESRTCIC at the Conference.

The Conference was attended by the Member States of the OIC and by some

other states with observer status. It was also attended by the subsidiary, specialised and affiliated institutions of the OIC as well as some International and Regional Organisations and some Islamic Foundations and Societies.

The Conference was opened by H.E. Dato Seri Dr. Mahathir bin Mohamed, Prime Minister of Malaysia. H.E. Dr. Azeddine Laraki, the Secretary General of the OIC, then delivered an extensive address on the activities of the OIC. After the adoption of the Agenda, the Conference continued to discuss its respective agenda items in the following committees on Muslims a) and Minorities. Political. Legal and Information Affairs, b) Economic and Social Affairs, c) Cultural and Islamic Affairs, d) Administrative and Financial Affairs.

After reviewing the activities of the OIC in the economic field, the Economic and Social Affairs Committee decided to take up the various resolutions one by one. The Committee deliberated on various important developments in the global economic scene, the international financial crisis, matters relating to WTO, debt and other issues of interest to Member States. At the end of its deliberations, the Committee adopted the relevant resolutions. Besides its regular assignments such as the annual reports on the World Economy, the Least-Developed countries, WTO activities, Regionalisation, Poverty and Debt, the Centre was entrusted a new topic entitled "Supporting the Reforms of International Financial Structure".

The Administrative and Financial Affairs Committee took up the Report of the 28<sup>th</sup>

Session of the Permanent Finance Committee, the Report of the 20<sup>th</sup> Meeting of the Finance Control Organ and the Report of the Second Meeting of the Intergovernmental Group of Experts Administrative and Structural Reforms of the OIC. After an extensive deliberation, the Committee adopted the above mentioned Reports and the recommendations contained therein. among which were the budget proposal of SESRTCIC for the Financial Year 2000/2001 and its Final Accounts for the Financial Year 1998/1999. The Committee also elected the new members of the Finance Control Organ and adopted certain amendments to the OIC Personnel Regulations.

The Conference elected H.E. Dr. Abdelouahed Belkeziz of Morocco as Secretary General of OIC for a four-year term as of 1<sup>st</sup> January, 2001. The Conference also elected Assistant Secretary Generals for Arab and African Groups and one from Saudi Arabia. The election of the Assistant Secretary General for Asia has been postponed to a forthcoming meeting.
